While stopping at Tragedy Springs for lunch, they found the site in need of maintenance and repairs. The rock behind the spring cover had been vandalized and tagged with paint. The sign that describes the site had been damaged and the support posts broken from snow damage.


California Pioneer History volunteers, Margo and Sumner Howes, Dick Williams, Virginia and Peter Guilbert, with retired USFS volunteer trek coordinator Frank Tortorich, organized a work party to restore the site. The workers replaced the posts with new ones and secured them in cement. Biodegradable paint cleaner was used to remove the paint. The leaves and debris surrounding the grave site were swept and removed. During lunch, Frank shared many interesting facts about the three scouts, Daniel Browett, Ezrah Allen, and Henderson Cox, for the Mormon Battalion. The men were murdered at the site and Frank described the scene as described in the journal entries.

#### Progress on the Mormon Worker's Cabin in Coloma

After their discharge from the military many members of the Mormon Battalion traveled north in California. Six of these battalion members hired on to assist John Sutter and James Marshall build a sawmill on the south branch of the American River. They built a cabin like this, completing it on January 23, 1848. Because of two of the battalion men's journals, we know the actual date that gold was discovered-January 24, 1848.

A replica of the cabin in which the mill workers lived, known as the Mormon Workers' Cabin, has been one of the features of the Marshall Gold Discovery State Historic Park for many years. Over the years it has been attacked by the sun, rain, dry rot, carpenter ants and termites. It is not only becoming unsafe to interpret but it is now located too far away from the newly completed replica of Sutter's Mill.

We have undertaken construction of a new replica cabin which will be located prominently near the Mill site. Today the cabin is maintained by California Living History volunteers, 25 from the El Dorado area. The volunteers staff the cabin year-round and explain the history of the Mormon Battalion and the six Mormon-boys (as Sutter lovingly called them) who helped him build the lumber mill.

Over 70,000 school children experience this rich history each year, and nearly 2 Million visitors from all over the world visit Marshall Gold State Historic Park and the Mormon Worker's Cabin.

# Natomas Dredge Crew Shack Rebuilt at Folsom Pioneer Village







The Dredge Office, a small building at the Folsom Pioneer Village was crushed by a large limb in August. The rebuild was completed in early December 2020.



Pioneer Village is an outdoor, living history museum. This interactive interpretive area includes gold panning and a working blacksmith forge. Here, you can explore a miner's cabin, a genuine Southern Pacific Railroad caboose and walk through historic Ashland Station. California Living History Specialists share stories of early California pioneers and their role in the discovery of gold. The Folsom Pioneer Village is located at 196 Wool Street, Folsom, California 95630 in Sacramento County. Hours are 10:00 am to 3:00 pm Tuesday-Sunday, weather permitting.





## **Coordinating Council Liaison Report**

To align California Living History Church-Service Missionaries connections with local leaders of The Church of Jesus Christ of Latter-day Saints, CLHM liaisons will now attend Coordinating Council Communication Council meetings. "What's a Coordinating Council Communication Council?" you ask.

Church leadership in California is divided into 15 Coordinating Councils. The boundaries for each CC match the boundaries of a proselyting mission. (See the map) Each CC has a CCCD – Coordinating Council Communication Director and a CC Communication Council that "helps coordinate relationships, events and issues that cross stake boundaries" and that offer "support and training to stake communication councils." (Gen Handbook 5.2.1.7).

CC liaisons from the CLHM will be a link in informing Church leaders about the CLHM and in recruiting new Church-Service Missionaries to serve California Living History missions. Currently there are 116 missionaries serving in 12 districts and geographic areas.





All of the CCCDs report to Elder Jay Pimentel, the Church's Communication Director for the North America West Area of the Church that includes all of California and additional West Coast States. Elder Pimentel has been an enthusiastic proponent of the CLHM for years and is excited to continue to work closely together with the CLH Church-Service Missionaries.

Three Generations of Corless Family March Together in the Parade

John's great, great, great-grandfather was Thomas Weir, a 3rd Corporal, Company A. in the Mormon Battalion. The following is an account John shares as a California Living History reenactor.

He left behind a wife who was 3 months pregnant. At one point, Thomas and a companion were captured by the enemy. They were taken to an adobe cabin and held captive. They managed to befriend the cook who told them that the enemy wanted to do away with them but they were not worth powder and ball. The cook advised them to be careful with food and drink given to them. They gave a bit of food given to them to a dog that was tied nearby before eating it. It was not long until the dog showed signs of poisoning and died.

Thomas and his companion realized that their only hope of survival was to make their escape which they did that evening. In making their escape, Thomas suffered a blow to the back of his head that affected him throughout his life. They ran and walked as best they could all night.

Following are Thomas's own words as quoted in the book 500 WAGONS STOOD STILL. "When dawn came, we were hungry, faint, and almost exhausted. We knelt down to pray and ask God to help and direct us. In a short time we came to a beaten trail. We followed it but a little distance when to our astonishment and gladness we found a soldier's knapsack well filled with food and water. From its contents we discerned that it belonged to one of our own company. We knew from the shoe tracks that the company was marching ahead." "the finding of the knapsack and our escape were miracles wrought by the hand of God, in answer to [our] prayers."




